PRAYER: Writ Petition filed under Article 226 of the Constitution of India to issue Writ of Mandamus directing the respondents to give permission and protection to conduct cultural events scheduled to be held on 23.02.2021 in connection with Arulmighu Sri Aathmanayagi Amman Sri Ruthrakodieshwarar Thirukovil, festival at Sathurvethamangalam (S.V.Mangalam) Singapunari Taluk, Sivagangai District.

O R D E R

By consent, this writ petition is taken up for final disposal at the stage of admission itself.

2. Mr.S.Chandrasekar, learned Additional Public Prosecutor accepts notice for the respondents.

3. Mr.V.Manikandan, learned counsel appearing for the petitioner would submit that the petitioner is one of the organizers of festival committee of Arulmighu Sri Aathmanayagi Amman Sri Ruthrakodieshwar Thirukovil at Sathurvethamangalam (S.V.Mangalam) Singapunai Taluk, Sivagangai District and that cultural events are scheduled to be held on 23.02.2021. His further contention is that he submitted a representation dated 15.02.2021 to the second respondent seeking permission to conduct the said programme and till date, no action has been taken by the respondents.

4. In the circumstances, without going into the merits of the claim made by the petitioner, this Court directs the second respondent to consider the representation of the petitioner and pass appropriate orders in accordance with law based on findings and on merits, within a period of two weeks from the date of receipt of a copy of this order/uploading of the order.



5. With the above observation, this writ petition is disposed of. No costs.
