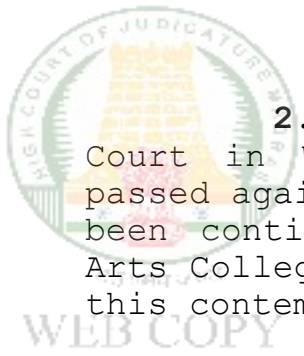
Prayer in WMP(MD) .2389/ 2021:
