4.When the matter is taken up for hearing, the learned Government Advocate (Cr1. side) appearing for the respondents submits that on receipt of the complaint, the respondent police



conducted the investigation and registered a case in Crime No.198 of 2021 for the offences punishable under Sections 468, 471, 406 and 420 of IPC, against the petitioner.

5.Under such circumstances, once the regular FIR has been registered, the question of "Not to harass" will not arise. Any direction issued by this Court at this stage will amount to interfering with the investigation conducted by the respondent police.

6.Hence, this Criminal Original Petition is closed.
