PRAYER :-

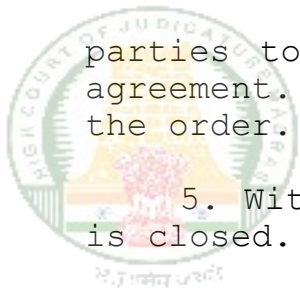
For Anticipatory Bail in Crime no.35 of 2020 on the file of
