produced before this Court in time on 17.03.2020.

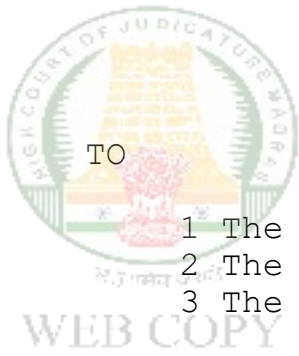
