This petition filed under section 482 of the Cr.P.C., To call for the records relating to the proceedings of the FIR in crime no.6 of 2019 dated 09/04/2019 on the file of the 1st respondent and quash the same in so far as against the petitioner is concerned and thus render justice.

ORDER:- This Revision/Appeal Petition coming on for orders on this day and upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of Thiru. M.Muthumanikkam Counsel for State, for the Petitioner and this Court made the following order:

The above Criminal Miscellaneous Petition is filed seeking orders to extend the time to complete the investigation and to file



final report.

2. This Court, vide order dated 16.03.2021, directed the petitioners/respondents to complete the investigation in the case registered in Cr.No.6 of 2019 and file a final report within a period six months from the date of receipt of a copy of that order.

3. The petitioners have come forward with the present application for extension of time alleging that 15 more witnesses have to be examined and ten more documents have to be collected.

4. Considering the submissions made by the learned Government Advocate (Crl.Side), this Court is inclined to grant further time to complete the investigation. Accordingly, three months' further time is granted to complete the investigation and file a report.

5. This Criminal Miscellaneous Petition is ordered accordingly.
