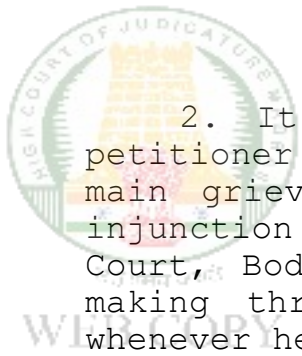

Petition filed praying that in the circumstances stated therein and in the petition filed therewith the High Court may be pleased to direct the 2nd Respondent to give suitable direction to the 3rd Respondent to give adequate Police protection for the life and limb of the Petitioner and his family members based on the representation dated 29.08.2020 and 17.02.2021 in the light of the order passed in I.A.No.2 of 2020 in O.S.No.39 of 2020 on the file of District Munsif Court, Bodinayackanur, Theni District.

Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.S.SARAVANAKUMAR, Advocate for the Petitioner and of Additional Public Prosecutor on behalf of the Respondents 1 to 3, the Court made the following order:-

This Petition has been filed seeking for Police Protection to the life and limb, based on the representation dated 29.08.2020.



2. It appears that a civil dispute is pending between the petitioner as well as the private respondents 4 to 7 herein. The main grievance of the petitioner is that, even though temporary injunction has been granted in O.S.39 of 2020 by the District Munsif Court, Bodinayakannur in I.A.No.2 of 2020, they are continuously making threat not only to the enjoyment but also to his life whenever he tries to enter in the property.

3. The learned Additional Public Prosecutor (Crl. Side) would submit that based upon the complaint given by the petitioner enquiry was undertaken in C.P.No.101 of 2021 and during the course of enquiry, the private respondents have given an undertaking that they will not make any trouble. Let the copies of the enquiry report be submitted by the learned Additional Public Prosecutor before this Court for further orders. List the matter on 01.07.2021.
