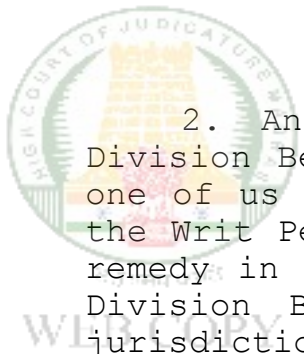

In tune with the order of the Division Bench, if the petitioner files a petition before the jurisdictional designated Court, such Court shall dispose of the same on merits and in accordance with law.

3. In the light of the above order, the writ petition stands disposed of with similar observations made in W.P.(MD).No.3998 of 2021. No costs.
