2. Mr.C.T.Perumal, learned counsel appearing for the petitioner would state that while granting suspension of sentence, this Court directed the petitioners to stay at Madurai and appear before the learned Judicial Magistrate No.I, Madurai at 10.30 a.m., on all working days, until further orders. It is further submitted that the petitioners are daily wagers and they are unable to go for working in view of the condition imposed by this Court and their



family is struggling, however, they have been complying with the condition from 25.01.2021.

3. We have heard the learned Additional Public Prosecutor appearing for the respondent.

4. Considering the submissions of the learned counsel for the petitioners, we are inclined to modify condition directing the petitioners to appear before the committal Court on the first working day of every month at 10.30 a.m., until further orders.

5. Accordingly, this petition is ordered.
