reminder dated 09.01.2021, we call upon the fourth respondent to pass appropriate orders on the same, in accordance with law. If any encroachments are found, appropriate action will have to be taken to remove the same, in the manner known to law. The aforesaid exercise will have to be completed within a period of eight weeks from the date of receipt of a copy of this order.

3. With the above directions, this writ petition stands disposed of. No costs.
