3.Today (23.12.2021), when the matter is taken up for hearing, it is reported by the learned counsel appearing for the third respondent that as directed by this Court, the third respondent has paid a sum of Rs.6,00,000/- (Rupees Six Lakhs only) to the



petitioner, towards arrear maintenance as well as future maintenance, vide Cheque No.329428 dated 15.12.2021, State Bank of India. The learned counsel for the petitioner also conceded the same.

4.The submission made on behalf of the third respondent is recorded. In view of the said submission, no further order is required.
