2.As per the said proceedings it transpired that on 09.03.2021 at about 4.30 pm, a peace committee meeting was held, in which all

4.In view of the above, no further orders are required to be passed in this writ petition. However, the parties are directed to comply with the nine resolutions passed in the peace committee meeting, which was held on 09.03.2021 without creating any law and order problem and also to extend their utmost co-operation for the smooth conduct of the festival.
