By consent, this Writ Petition is taken up for final hearing at the admission stage itself.

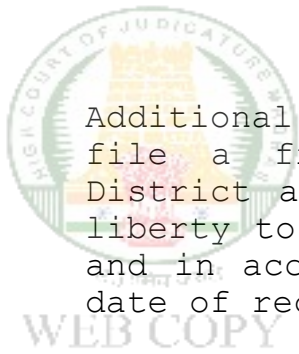
2. Mr.S.Chandrasekar, learned Additional Public Prosecutor accepts notice for the respondents.

3. Mr.V.Manikandan, learned counsel appearing for the petitioner would submit that the petitioner is one of the members of the festival committee of Arulmighu Sri Murugan Thirukoil, Erumarpatti, Usilampatti Taluk, Madurai District and that cultural event is scheduled to be held on 04.03.2021. His further contention is that he submitted a representation dated 16.02.2021 to the respondents seeking permission to conduct the said programme and till date, no action has been taken by the respondents.

4.The contention of Mr.S.Chandrasekar, learned Additional Public Prosecutor is that as per G.O.(Ms)No.654 (Revenue and Disaster Management (DM-IV) Department) dated 21.11.2020, the District Collector is the competent authority to consider the request of the petitioner.
