PRAYER :- For Anticipatory Bail in Crime No.4 of 2020 on the file of the Respondent Police.

3.The learned counsel for the petitioners would submit that on knowing the information about the dismissal of the anticipatory bail application, they have not appeared before the respondent police.

4.Whatever it may be, a Special Team was formed to secure the accused. Since this Criminal Original Petition was already disposed



(Crl.Side), now, it is closed with a direction to the respondent police to comply the condition passed by this Court, dated 17.09.2021.
