3. Be that as it may, we do not wish to go into the merits, in view of the pendency of the representation. In such view of the matter, the respondent No.2 is directed to pass appropriate orders



on the same, within four weeks from the date of receipt of a copy of this order.

4. The writ petition stands disposed of accordingly. No costs.
