Prayer : This Criminal Revision has been filed under Section 397 r/w 401 of Criminal Procedure Code, to allow the revision and set aside the judgment, dated 24.08.2020 in C.A.No.65 of 2018 on the file of the 4th Additional District and Sessions Judge, Tirunelveli, confirming the sentence imposed by the trial Court in S.T.C.No.65 of 2013, dated 28.05.2018 on the file of the Judicial Magistrate No.3, Tirunelveli convicting the petitioner to pay a fine of Rs.1,000/- in default to undergo 1 month simple imprisonment for the offence under Section 279 IPC and to pay a fine of Rs.500/- for each count in default to undergo 1 month simple imprisonment for the offence under Section 337 (4 counts) IPC and to undergo 3 month simple imprisonment and to pay a fine of Rs.1,000/- in default to undergo 1 month simple imprisonment for the offence under Section 338 IPC.
