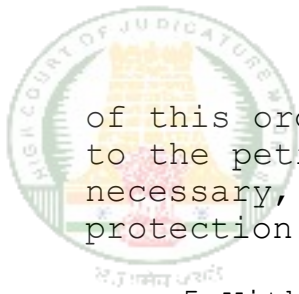
ORDER

3.Mr.A.Robinson, learned Government Advocate (Criminal Side), who accepts notice for the respondents 1 to 3 on instructions, would contend that the petitioner's representation was registered in CSR No.76 of 2021 and posted for enquiry.

4.Recording the submission of the learned Government Advocate (Criminal Side), the second respondent is directed to pass appropriate orders on the representation submitted by the petitioners, based on findings and on merits and in accordance with law, within a period of two weeks from the date of receipt of a copy



of this order / uploading of this order, after affording opportunity to the petitioner and the private respondents. In the meanwhile, if necessary, the respondent police shall give adequate police protection to the petitioner.

5. With the above observation, this Criminal Original Petition is disposed of.
