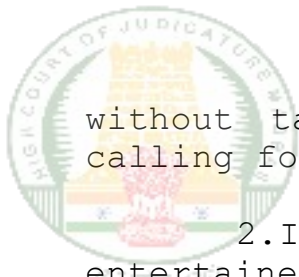

3. However, It is open to the petitioner to approach this Court by filing proper affidavit cohesively with certain amount of clarity as to what relief he is intended to seek, if he is so advised. No costs. Consequently, connected miscellaneous petition is closed.
