It is stated that the respondents have preferred an appeal against the order of the writ court and stay has also been granted in C.M.P.(MD).No.115 of 2021 in W.A.(MD).No.25 of 2021. When the Honourable Division Bench has taken cognizance of the matter, it would not be appropriate to simultaneously adjudicate the contempt



petition. Hence, the contempt petition is closed. However, in case, the petitioner is of the view that the disobedience continues even after the final disposal of the writ appeal itself, if it is in his favour, it is open to the petitioner to exercise his rights with regard to such disobedience, in accordance with law.
