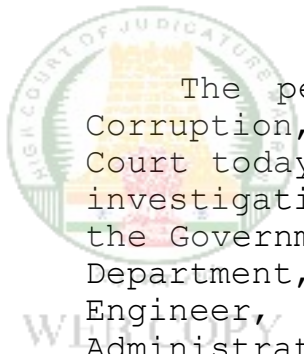
Prayer in Crl M.P(MD) .No.2513/2021:-
