2.The petitioner has come forward with this petition for issuance of a Writ of Mandamus directing the second respondent to



transfer the petitioner's husband, by name, S.Murali, CT No.23437 from Central Prison, Trichy to Puzhal Central Prison, Chennai, based on her representation, dated 24.02.2021.

3.The learned Additional Public Prosecutor would state that the representation of the petitioner was considered and by an order, dated 19.03.2021, the petitioner husband was directed to be transferred from Central Prison, Trichy to Puzhal Central Prison, Chennai. A copy the said order has been placed before this Court for perusal.

4.In the light of the above fact, we are of the opinion that the prayer sought for in this writ petition has become infructuous. Accordingly, this writ petition is dismissed as infructuous.

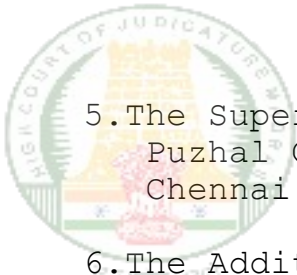
