(3) That there be no costs in this Civil Miscellaneous Appeal.

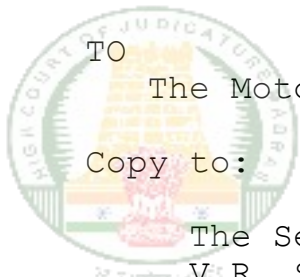
