For Respondents 1 to 3 : Mr.A.Robinson

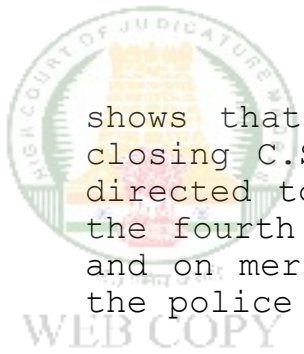
