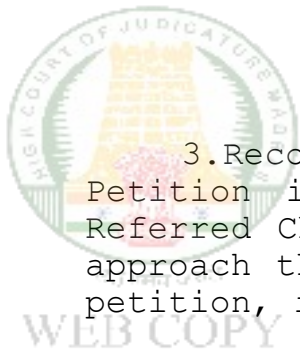

3. Recording the said submissions, the Criminal Original Petition is disposed of. If the petitioner is aggrieved by the Referred Charge Sheet (RCS) filed by the second respondent, he can approach the concerned Jurisdictional Magistrate and file a protest petition, if so advised.
