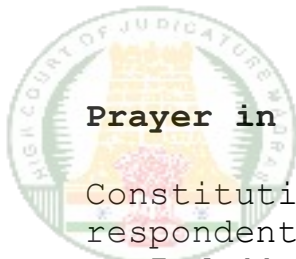

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court directing the respondents 1 and 2 to instruct the 3rd respondent to pay at least Rs.7 lakhs within a week to meet the petitioner immediate needs and to repay the maturity amount of the balance deposits by fixing a time frame with interest as agreed in the Bonds until repayment and without brake, with further interest as per the terms of bond until repaid / on the due dates of maturity without further delay, ensure the instructions are carried out strictly, or issue suitable writ or order(s) as expedient to the facts and circumstances of the matter
