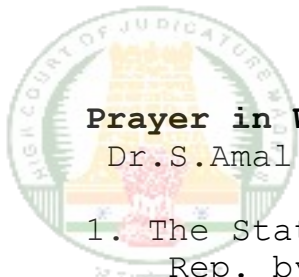

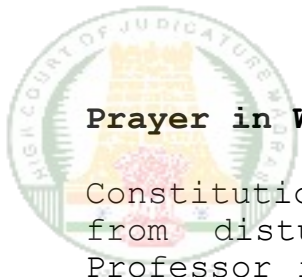

The petitioners also sought for a direction for regularization of their service, grant of monitory benefits including yearly increments, etc.

2. When the matters are taken up for hearing, the learned Additional Advocate General would submit that the petitioners have been accommodated as Assistant Professors in Anna University.
