ORDER

(Order of the Court was made by M.M.SUNDRESH, J.)

The petitioner has challenged the impugned proceedings, by which Administrative Sanction was given to carry out the work. The grievance of the petitioner is that the work is being allotted to only one person, by name, Kulanthaisamy.

2. The learned Additional Government Pleader appearing for the official respondents submitted that 75% of the work has already been completed.

3. We are not inclined to entertain this writ petition on two grounds, namely, the tender process has not been put into challenge and the work is nearing completion. However, taking into consideration of the representation dated 26.02.2021 made by the petitioner towards the first respondent / Inspector of Panchayats, the said respondent is directed to look into the same and pass appropriate orders, in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.

4. In fine, this writ petition stands disposed of. No costs. Consequently, connected miscellaneous petitions stand closed.
