2. The learned counsel for the petitioner submitted that the petitioner is abiding the condition imposed by this Court without any deviation and prayed the condition to be relaxed.

3. On the side of the respondent, it is stated that the petitioner complied the condition from 02.01.2020 till 24.03.2021 and again from 02.12.2020 till today (11.03.2021).

4. It is seen that the petitioner has complied the condition except during the lock down period. In the above circumstances, the condition already imposed on the petitioner is relaxed and the



petitioner is directed to appear before the lower Court as and when required by the Court. Accordingly, this petition is allowed.
