3.Mr.V.Manikandan, learned counsel appearing for the petitioner would submit that the petitioner is one of the organizers of the festival committee of Arulmighu Sri Muthumariamman Thirukovil at Keelaikudi @ Thennalagapuri, Ilayankudi Taluk, Sivagangai District and that cultural events are scheduled to be held on 23.03.2021. His further contention is that he submitted a representation dated 06.03.2021 to the respondents seeking permission to conduct the said programme and till date, no action has been taken by the respondents.



4.The contention of Mr.A.Robinson, learned Government Advocate (Criminal Side) is that as per G.O.(Ms)No.654 (Revenue and Disaster Management (DM-IV) Department) dated 21.11.2020, the District Collector is the competent authority to consider the request of the petitioner.

5.In the facts and circumstances, the District Collector, Sivagangai District is at liberty to pass appropriate orders on the representation submitted by the petitioner, based on merits and on findings and in accordance with law, within a period of two weeks from the date of receipt of a copy of this order/uploading of this order.

6.With the above observation, this petition is disposed of. No costs.
