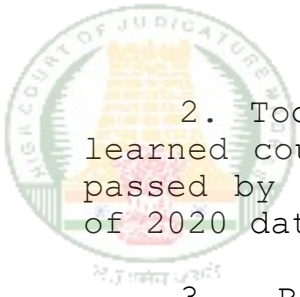
Prayer in WP(MD). 468/ 2020 :
