The petitioner's Clubs was entitled to conduct lawful activities in its premises and also could conduct entertainment programmes, but, the second respondent illegally trespassed into the premises of the Club and prayed for a direction to take action against the



3. On the side of the respondents, it is stated that a complaint was received against the petitioner and the same was treated as C.S.R.No.33 of 2021 and hence, the respondents entered into the premises of the petitioner's Club.

4. Since the C.S.R. has been assigned, the petitioner is directed to co-operate with the enquiry.

5. With the above direction, this Writ Petition is closed.
