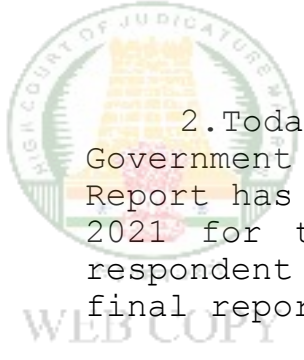
PETITION FOR ANTICIPATORY BAIL Under Sec.438 of Cr.P.C

PRAYER :-

For Anticipatory Bail in Crime No.Not Known of 2021 on the file
of the Respondent Police.

ORDER : The Court made the following order :-

The petitioners/ accused, who apprehend arrest at the hands of
the respondent police for the alleged offences punishable under
Sections 406 and 468 of IPC, in Crime No.not known of 2021, seek
anticipatory bail.



2.Today, when the matter is taken up for hearing the learned Government Advocate(Crl.Side) submitted that the First Information Report has been registered against the petitioners in Crime No.10 of 2021 for the offences under Section 420 of IPC. Thereafter, the respondent police has completed the investigation and also filed final report as ' Action Dropped' and the same has been closed.

3.In view of the same, the petition is dismissed with liberty to the intervener to work out his remedy before the concerned Magistrate in the manner known to law. Consequently, the connected criminal miscellaneous petition is also dismissed.
