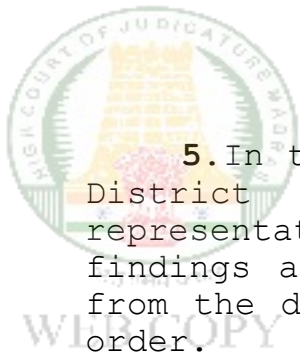
ORDER

2.Mr.S.Chandra Sekar, learned Additional Public Prosecutor accepts notice for the respondents.

3.Mr.V.Manikandan, learned counsel appearing for the petitioner would submit that the petitioner is an organizer of the festival committee of Arulmigu Sri Bagavathi Amman Thirukovil at Palarpatti, Bodinayakanoor Taluk, Theni District and that cultural events are scheduled to be held on 24.03.2021. His further contention is that he submitted a representation dated 16.03.2021 to the respondents seeking permission to conduct the said programme and till date, no action has been taken by the respondents.

4.The contention of Mr.S.Chandra Sekar, learned Additional Public Prosecutor is that as per G.O.(Ms)No.654 (Revenue and Disaster Management (DM-IV) Department) dated 21.11.2020, the District Collector is the competent authority to consider the request of the petitioner.

In the facts and circumstances, the District Collector, Theni District is at liberty to pass appropriate orders on the representation submitted by the petitioner, based on merits and on findings and in accordance with law, within a period of two weeks from the date of receipt of a copy of this order/uploading of this order.

6. With the above observation, this petition is disposed of. No costs.
