4.In view of the above, there shall be a direction to the respondents to consider the representation of the petitioner dated 01.10.2019, for issuance of his OMR sheet, within a period of twelve [12] weeks, from the date of receipt of a copy of this order.

5.With the above direction, this Writ Petition stands disposed of. However, there shall be no order as to costs.
