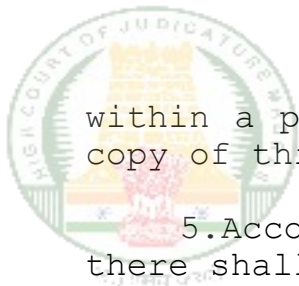
O R D E R

By consent of both parties, this writ petition is taken up for final disposal at the stage of admission itself.

2.The learned Counsel for the petitioner would submit that the petitioner was appointed as Anti Poaching Watcher on 01.04.2000. Even after completion of 10 years of service, the petitioner's name is not considered for regularisation of his service. Hence, the petitioner sent a representation dated 26.09.2020, to the respondents. Since, the representation of the petitioner is still pending consideration, the present writ petition has been filed.

3.Learned Counsel for the petitioner would submit that this Court may issue a direction to the respondents to consider the representation of the petitioner dated 26.09.2020.

4.In view of the above, this Court directs the respondents to consider the representation of the petitioner dated 26.09.2020,



within a period of twelve [12] weeks from the date of receipt of a copy of this order.

5. Accordingly, this Writ Petition is disposed of. However, there shall be no order as to costs.
