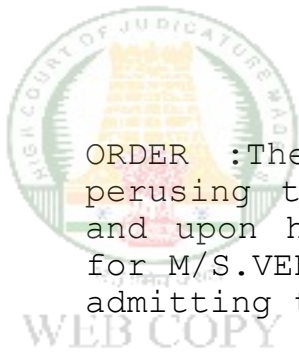
COMMON PRAYER IN WMP(MD) Nos.5217 and 5223 of 2021:
