Prayer in CRL MP(MD) . No.4635 of 2021:-

This petition filed under Section 482 of Cr.P.C, praying this to pass an order of extent the time for paying balance of cheque amount for a further period of three months in Crl.R.C.No.872 of 2016 dated 07/12/2020.
