O R D E R

By consent of both parties, this writ petition is taken up for final disposal at the stage of admission itself.

2.The case of the petitioner is that the petitioner is working as Conductor in the respondent Corporation. The petitioner served as a Conductor in his native place. While so, by order dated 26.02.2021, he was transferred from Colachel Depot to Vivekananthapuram Depot. Thereafter, the petitioner made a representation dated 02.03.2021, to reconsider the said transfer order. Since, the said representation has not been considered so far, the petitioner has come up with the present writ petition.

3.Learned Counsel for the petitioner would submit that this Court may issue a direction to the respondents to consider the representation of the petitioner dated 02.03.2021.

4.In view of the above, this Court directs the respondents to consider the representation of the petitioner dated 02.03.2021, within a period of twelve [12] weeks, from the date of receipt of a copy of this order.



5. Accordingly, the Writ Petition stands disposed of. However, there shall be no order as to costs.
