Order : This petition coming up for orders on this day, upon perusing the petition filed in support thereof and upon hearing the arguments of Mr.D.VENKATESH, Advocate for the petitioner and of Mr.M.V.CHANDRASEKARAN, Government Advocate(criminal side) on behalf of the Respondent, the court made the following order:-

This petition is filed to extend the time limit of the petitioner surrender and execute sureties in Crl.O.P(MD)No.3150 of 2021, dated 01.03.2021.

2.The learned counsel for the petitioner would submit that there is a delay in mobilising Rs.25,000/- and now the petitioner drew Demand Draft for the same. Hence, there was a delay occurred in executing sureties.

3.Considering the reasons stated in the petition, time for surrender by the petitioner before the concerned Court and executing the sureties is extended by two weeks from the date of receipt of a copy of this order, failing which the anticipatory bail already granted by this Court shall stand cancelled. It is made clear that no further extension will be granted. If the petitioner is not complied with the order within the stipulated period, the respondent police shall secure the petitioner.



4. Accordingly, this Criminal Miscellaneous Petition is allowed.
