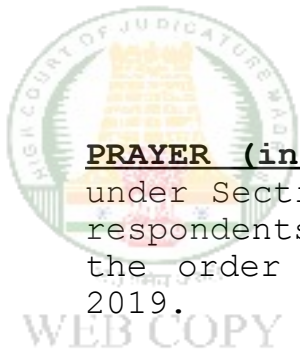

3. Recording the same, the contempt petitions are closed.

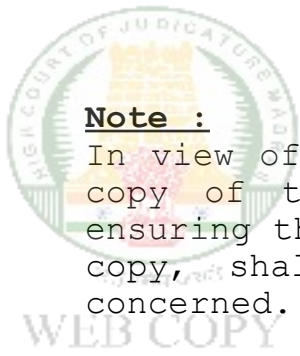
