Assistant Commissioner of Police, Annanagar (L&O) Range, Madurai City, Madurai and Others** reported in **2018 4 MLJ (Cr1) 585** and



Thirumagan Vs. The Superintendant of Police, Madurai District
reported in 2020 (2) LW (Cr1) - 266.

4. With the above observation, this writ petition is disposed of. No costs.
