PRAYER : Petition is filed under Article 226 of the Constitution of India praying for the issue of a Writ of Habeas Corpus calling for the entire records connected with the detention order passed in H.S.(M)Confdl.No.40 of 2021, dated 10.3.2021, on the file of the second respondent herein and to quash the same and to direct the respondents to produce the detenu or body of the detenu namely, Mariappan @ Soup Mariappan, aged about 60 years, son of Veilukantha Muthaliyar, now detained at the Central Prison, Palayamkottai, before this Court and set him at liberty forthwith.

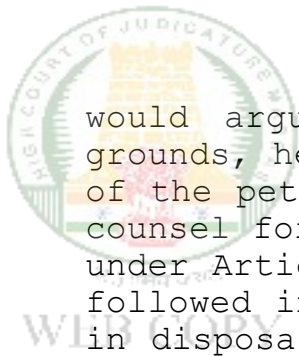

O R D E R

(Order of the Court was made by K.KALYANASUNDARAM, J.)

This habeas corpus petition has been filed by the detenu, namely, Mariappan @ Soup Mariappan, son of Veilukantha Muthaliyar, aged about 60 years, challenging the detention order in H.S.(M) Confdl.No.40 of 2021, dated 10.3.2021, passed by the second respondent, branding him as "Drug Offender" as contemplated under Section 2(e) of Tamil Nadu Act 14 of 1982.

2. Mr.N.Pragalathan, learned counsel for the petitioner,

would argue that even though the petitioner has raised several grounds, he has confined his arguments only to the delay in disposal of the petitioner's representation. It is submitted by the learned counsel for the petitioner that the procedural safeguards guaranteed under Articles 21 and 22 of the Constitution of India have not been followed in this case and there is unexplained and inordinate delay in disposal of the petitioner's representation, which would vitiate the impugned order of detention.

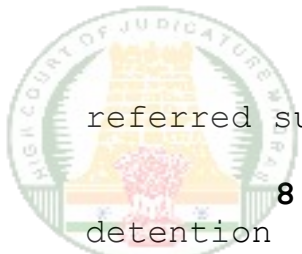
3. Mr.S.Ravi, learned Standing Counsel for the State, on instructions, submitted that after satisfying with the materials placed by the Sponsoring Authority, the Detaining Authority has passed the detention order and there is no illegality or infirmity in the detention order. It is also stated that even if there is any delay in disposal of the representation, it has not caused any prejudice to the rights of the detenu and hence, prayed for dismissal of the habeas corpus petition.

4. Heard both sides and perused the materials available on record.

5. In the instant case, the pro-forma furnished by the learned Standing Counsel for the State would indicate that as against the impugned detention order, the petitioner made a representation to the first respondent on 22.3.2021 and it was received on 29.3.2021. Remarks were called for on 30.3.2021 and it was received on 8.4.2021. The Deputy Secretary dealt with the matter on 8.4.2021. The concerned Minister dealt with the matter on 19.4.2021 and the representation came to be rejected on 20.4.2021. It is seen that in between 30.3.2021 and 8.4.2021, there was a delay of 8 days, after excluding the Government Holidays of 4 days, there was a delay of 4 days in the first part and in between 8.4.2021 and 19.4.2021, there was a delay of 10 days and after excluding the Government Holidays of 6 days, there was a delay of 4 days in the second part, in considering the petitioner's representation.

6. At this juncture, it is useful to refer the decision of the Honourable Apex Court in the case of ***Rajammal vs. State of Tamil Nadu and another***, reported in **1999 (1) SCC 417**, wherein, the Apex Court has observed and held that it is for the Authority concerned to explain the delay, if any, in disposal of the representation and if any delay was caused on account of nay indifference or lapse in considering the representation, such delay will adversely affect further detention of the prisoner.

7. In the case on hand, as stated supra, the delay of 8 days in considering the representation of the petitioner remains unexplained by the respondents. Hence, in our considered view, the detention order is liable to be set aside solely on the ground of delay by following the decision of the Honourable Apex Court



referred supra.

8. In fine, the Habeas Corpus Petition is allowed. The detention order in H.S.(M)Confdl.No.40 of 2021, dated 10.3.2021 passed by the second respondent, is set aside. Consequently, the detenu, namely, Mariappan @ Soup Mariappan, son of Veilukantha Muthaliyar, aged about 60 years, who is now detained at Central Prison, Palayamkottai is directed to be released forthwith unless his presence or custody or detention is required in connection with any other case.
