ORDER

The present petition is filed by the petitioners under Section 482 of the Code of Criminal Procedure, praying to direct the second respondent not to harass the petitioners and their family members.

2.Mr.A.Robinson, learned Government Advocate (Criminal side), who accepts notice on behalf of the respondents 1 and 2, on instructions, would submit that the third respondent lodged a complainant with the second respondent against the petitioner and the same was registered in C.S.R.No.232 of 2021 and posted for enquiry. His specific contention is that the respondent police never harassed the petitioners.

3.Recording the submissions made by the learned Government Advocate (Criminal side), the respondents 1 and 2 /police are



directed to follow the guidelines issued in the decisions in **D.K.Basu Vs. State of West Bengal** reported in **AIR (1997) SC 610** and **Lalitha Kumari Vs. Government of Uttarpradesh** reported in **(2014) 2 SCC 1**.

4. With the above observation, this Criminal Original Petition is disposed of.
