Writ Petition is filed under Article 226 of the Constitution of India, praying this Court Direct the respondents to pay interest at the rate of 18 percent per annum, for the period of delay from 01.01.19 to 21.09.19, in paying the amounts paid towards the terminal and pension benefits of the petitioner namely EPF employees Contribution, Gratuity, Encashment of Earned/Sick Leaves and Commutated Value of Pension.

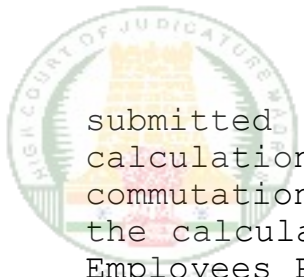

ORDER

The present Contempt Petition has been filed alleging non compliance of the order dated 07.01.2020, made in W.P.(MD)No.196 of 2020.

2. The learned counsel appearing for the respondents submitted that the interest amount payable to the petitioner was calculated and paid through ECS to the bank account of the petitioner.

3. However, the learned counsel appearing for the petitioner

submitted that the petitioner has no objection insofar as the calculation made by the respondent corporation. Insofar as commutation of pension is concerned, the petitioner is disputing the calculation made by the Tamil Nadu State Transport Corporation Employees Pension Fund Trust, as there is a huge difference.
