Today, the learned Additional Public Prosecutor would submit that based upon the complaint given by one Malaisamy, who is the father of the petitioner herein, a case in Crime No.486 of 2021, for the offences punishable under Sections 294(b), 417 IPC has been registered against one Balamurugan and Manikandan on 09.08.2021.

4. Since the grievance of the petitioner has been redressed, nothing survives for further consideration or direction in this petition. Recording the submission made by the learned Additional Public Prosecutor, this Writ Petition is disposed of as infructuous. No costs.
