Prayer in CRL MP(MD). No.2834 of 2021 :-

Criminal Miscellaneous Petition is filed under section 482 of Criminal Procedure Code, praying this Hon'ble Court to relax the condition imposed on the petitioner in Crl.A.(MD) No.375 of 2020 by order dated 09/02/2021.

2. The learned counsel for the petitioner submitted that the petitioner is abiding the condition imposed by this Court without any deviation and the investigation was over and charge sheet filed.

Hence, he prayed the condition to be relaxed.



3. The learned Government Advocate (criminal side) fairly admitted that the petitioner is complying with the condition regularly.

4. In the above circumstances, the condition already imposed on the petitioner is relaxed and the petitioner is directed to appear before the lower Court as and when required by the Court. Accordingly, this petition is allowed.
