PRAYER :- For Anticipatory Bail in Crime No. 10/2020 on the file
of the Respondent Police

ORDER : The Court Made the following order :-

It is seen from the submission of the learned counsel for the petitioner and the learned Additional Public Prosecutor appearing for the respondent that by the order dated 18.12.2020 in CrI.O.P.No.15218 of 2020, this Court had granted anticipatory bail to the petitioner with certain conditions. One of the conditions in the earlier order is that the petitioner shall produce two blood related sureties. However, due to the pandemic situation, he could not produce the blood related sureties within a time stipulated in the bail order.

2.The petitioner has to file a petition for modification of condition and should not file a fresh anticipatory bail petition.
