2. Though the Writ Petition has been filed seeking for direction to the Second Respondent to grant incentive increment to the Petitioner for acquiring B.Lit. B.Ed. and M.A. Degrees along with other consequential benefits, Learned Counsel for the Petitioner submits that the Petitioner would be satisfied if her representation dated 01.02.2021 made to the Second Respondent in that regard is disposed within a time frame stipulated by this Court and would confine her claim to that extent. Learned Counsel for the Petitioner has also filed a memo to that effect.

3. Having regard to the aforesaid submission made, this Court without expressing any view on the correctness or entitlement of the claim made by the Petitioner, requires the Second Respondent to dispassionately consider the claim made by the Petitioner in her representation dated 01.02.2021, after affording an opportunity of personal hearing to her and pass reasoned orders on merits and in accordance with law, communicate the decision taken under written acknowledgment and file report of such compliance before the Registrar (Judicial) of this Court by 30.06.2021.

4. In fine, the Writ Petition is disposed on the aforesaid terms. No costs.
