Prayer: This Petition filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the entire records of the second respondent insofar as the High Tension Bill (Provisional) for the months of April 2020 dated 04.05.2020, May 2020, dated 06.06.2020 and June 2020 dated 03.07.2020, pertaining to High Tension Consumer Connection vide Service No. 079094720186 and quash the same and consequently direct the respondents to rework the HT Bill with Service No.079094720186 and the excess amount shall be adjusted towards the future bills by levying the minimum charges alone by the second respondent for months of April 2020, May 2020 and June 2020 and not to levy any penalty for the lock down period under which the petitioner's Textiles Showroom cum Departmental stores building Situated at No.4-A, B, C-Sathyamurthy Street, Tirunelveli Town, Tirunelveli-627 006.
