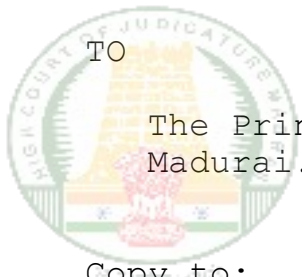
2. That the rate of interest be and hereby is reduced to 10% p.a.from 12% p.a.
